#### Primary responsibilities for this position include:

- > Performing investigative projects under the direction of senior Cornucopia staff.
- > Reviewing published scientific reports and literature
- > Developing documents and reports on investigative projects.
- ➤ Interacting with farmers, corporate officials, retailers, other NGOs and the media.
- ➤ Providing materials for news releases and for posting on Cornucopia's web page, in Cornucopia's newsletter, *The Cultivator*, and with its social media outreach.
- Attending relevant conferences and meetings (governmental, agricultural, trade shows, networking with other NGOs, etc.).

The ideal candidate would also possess experience working in a corporate or nonprofit environment with a skill set including:

- > Strong understanding (with applicable professional/academic background) of agricultural policy, nutrition and organic food and farming issues.
- > Commitment to the mission of The Cornucopia Institute.
- > Self-starter and ability to work independently.
- > Strong oral and written communication skills.
- Ability to interact effectively with volunteers, members, staff, media and the general public.
- Superior work ethic and careful attention to detail.
