ALLEGED VIOLATION file to be for the second time (first complaint was in Dec 2010 and was closed due to lack of evidence) against Diamond D Organics for altering a certificate, in violation of USDA organic regulations.

SUMMARY:

The NOP Compliance and Enforcement Division received a second complaint from $\binom{(b)}{(6)}, \binom{(b)}{(7)}, \binom{(b)}{(7)}, \binom{(b)}{(7)}$ filed on December 19, 2012, alleging that Daniel Lehenbauer altered its certificate to sell hay as certified organic, in violation of USDA organic regulations. $\overset{(b)}{(6)}, \overset{(c)}{(2)}, \overset{(c)}{(2)},$

A request to investigate was sent to GOA, August 22, 2013. That same day GOA responded attaching a copy of the altered certificate found in (0, (0, (7)(C), (0, (7)(C))), but could not provide a reason why the certificate was there. GOA stated that she has alerted her staff to be on the lookout for the altered certificate. (b) (6), (b) (7)(C), (b) (7)(D) purchased hay from is not a GOA client but is certified by (b) (6), (b) (7)(C)

A request to investigate was sent to regarding the possible purchase and sale of hay from a suspended operation.

The U.S. Department of Agriculture, National Organic Program (NOP) received a complaint alleging that Daniel Lehenbauer altered and used an expired organic certificate, in violation of USDA organic regulations. Specifically, the complaint states that Daniel Lehenbauer, initially certified by OneCert, was suspended in 2010. Mr. Lehenbauer allegedly altered his certificate and continued to sell and transport hay as organic. The altered certificate was discovered during an audit of provide (Organic Alliance (GOA).

The NOP in its communication with your client determined that the altered certificate was given to him by another of GOA's clients, (0) (6), (b) (7)(C) received the altered certificate when he purchased hay from Daniel Lehenbauer.

Further, you are required to have procedures for investigating certified operation noncompliance under the regulations at 205.504(b)(2). However, we realize that there may be some investigations with which you need assistance and you may refer the investigation back to the NOP for one or more of the following reasons:

- You lack the resources or the specialized expertise needed to adequately investigate the complaint;

The U.S. Department of Agriculture, National Organic Program (NOP) received a complaint alleging that Daniel Lehenbauer altered and used an expired organic certificate, in violation of USDA organic regulations. Specifically, the complaint states that Daniel Lehenbauer, initially certified by OneCert, was suspended in 2010. Mr. Lehenbauer allegedly altered his certificate and continued to sell and transport hay as organic. The altered certificate was discovered during an audit of (010)(010)(010)(010)(010)

The NOP in its communication with your client determined that the altered certificate was given to him by another of GOA's clients, (b) (6), (b) (7)(C) stated that by (7)(C), (b) (6) received the altered certificate when he purchased hay from Daniel Lehenbauer.

GOA has two clients named^{(b) (6), (b) (7)(C)} located in Pennsylvania. The NOP contacted both of these clients (b) (6), (b) (7)(C) of (b) (6), (b) (7)(C) stated he never purchased hay from Daniel Lehenbauer. (b) (6), (b) (7)(C) has not replied to the NOP's request for information.

The NOP requests that you investigate these allegations within 30 days of receiving this letter. Within 45 days of receiving this letter, please notify the NOP of your findings and of any notices of noncompliance or proposed adverse actions that you issued as a result of the investigation. At that time, assuming no additional action is needed the NOP will inform the complainant of your investigation's outcome. Also, if your investigation will take more than 30 days from the receipt of this letter, please inform the NOP.




